Accountants are finance and information specialists who inform business decisionmaking within a wide range of organisations. Management

Managers drive organisational culture, performance and results by leading, supporting and transforming organisations and their employees. Study management to formally develop the skills required to be an effective leader through a progressive program of theory and practice.

Marketing

Disciplines

Organisational psychology

Organisational psychologists apply science to the workplace to improve employee performance and wellbeing. You could work with organisations, teams and individual employees to devise strategies to recruit, motivate, develop, change and inspire your workforce.

People management

People management is one of the fastestgrowing fields of professional employment. This study area provides skills and understanding of the critical dimensions required to successfully manage people. Develop an understanding of strategic human resource development and management, organisational behaviour, change management, workplace counselling and negotiation, and an understanding of employment relations.

Project management




